WHEREAS, Tennessee Code Annotated Section 8-35-116(2) allows county judges and officials to claim prior service credit for service rendered as a full-time county general employee, county judge or county official; and

WHEREAS, the chief legislative body of the county must authorize and assume the liability for such prior service; and

WHEREAS, an actuarial study is required to determine the associated liability prior to final authorization; now, therefore,

funds for an actuarial study of the cost(s) of prior service for county judges and county officials; and

1. The actuarial study shall assume that the employer will not purchase prior service but said employer will accept the unfunded liability if the employee should elect to establish prior service.
2. There is hereby appropriated from the general fund such amount required to pay for the cost of said actuarial study.




