RESOLUTION TO ESTABLISH SPEED ZONE ON BEASLEY ROAD,  
CROWDER ROAD AND SALEM WOODS SUBDIVISION

WHEREAS, Beasley Road is a county road that runs from Buffalo Road to South Mt. Arat Road in Lawrence County, Tennessee; and

WHEREAS, the Lawrence County Legislative Body deems that the public safety requires a lower speed limit on Beasley Road between Buffalo Road and South Mt. Arat Road and that such speed limit should be 25 miles per hour; and

WHEREAS, Crowder Road is a county road that is located between Prosser Road and Fall River Road in Lawrence County, Tennessee; and

WHEREAS, the Lawrence County Legislative Body deems that the public safety requires a lower speed limit on Crowder Road between Prosser Road and Fall River Road and that such speed limit should be 45 miles per hour; and

WHEREAS, the Salem Woods Subdivision, located off Granddaddy Road, in Lawrence County, Tennessee, contains two streets, namely, Hawthorne Drive and Salem Lane; and

WHEREAS, Lawrence County Legislative Body deems that the public safety requires a lower speed limit on Hawthorne Drive and Salem Lane and that such speed limit should be 25 miles per hour.

NOW, THEREFORE, be it resolved by the Lawrence County Legislative Body meeting in regular session this 25th day of July, 1994, that the speed limit on Beasley Road and Crowder Road be and is hereby established at 25 miles per hour.

BE IT FURTHER RESOLVED that the speed limit on the roads contained in Salem Woods Subdivision, namely Hawthorne Drive and Salem Lane be and is hereby established at 25 miles per hour.

BE IT FURTHER RESOLVED that the county road superintendent for Lawrence County is hereby requested to erect appropriate signs and traffic signals to reflect the speed limits herein established on said roads.

This resolution shall take effect upon its passage, public welfare requiring it.

Resolution creating the 1996 Tennessee Bicentennial Committee of Lawrence County.

WHEREAS, June 1, 1996, will mark the bicentennial of Tennessee's admission to the Union. It is fitting that an event of this magnitude should be commemorated by the counties of the state of Tennessee. Such an event symbolizes achievement and growth and should remind the people of Lawrence County that the past shapes our present and gives hope for a productive future.

The Board of Commissioners of Lawrence County hereby enacts the following measures to commemorate this historic event: now, therefore,

BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF LAWRENCE COUNTY, That there is hereby created the 1996 Tennessee Bicentennial Committee of Lawrence County. Such committee shall be composed of eleven (11) citizens of Lawrence County who shall be appointed by the County Executive and certain ex-officio members who shall have a voice but no vote on the committee. All citizens members shall serve until April 15, 1997, at which time the 1996 Tennessee Bicentennial Committee of Lawrence County shall cease to exist. Ex-officio members shall serve on the committee only for so long as they serve in the office from which they were appointed. No more than two (2) members of the Board of Commissioners of Lawrence County may serve as voting, citizen members of the committee.

BE IT FURTHER RESOLVED, That if any vacancy shall occur in the membership of the committee, such vacancy shall be filled by the County Executive in accordance with the original appointing authority.

BE IT FURTHER RESOLVED, That the committee shall elect from among its voting members a chairperson, vice-chairperson and secretary. Thereafter, the committee shall meet at the call of the chair or upon the written request to the chair of no less than six (6) voting members. The committee shall appoint and empower such subcommittees as it deems necessary.

BE IT FURTHER RESOLVED, That the 1996 Tennessee Bicentennial Committee of Lawrence County shall report its findings and recommendations for programs, activities and ceremonies celebrating the Tennessee Bicentennial to the Board of Commissioners of County from time to time as appropriate to accomplish its legislative mandate and stated goals.

BE IT FURTHER RESOLVED, That the 1996 Tennessee Bicentennial Committee shall develop a comprehensive program for celebrating the bicentennial of Tennessee's admission to the union in Lawrence County. The program shall be developed to represent the contributions of all peoples and cultures to Tennessee state history and to the maximum feasible extent shall be designed to encourage and support participation in the bicentennial by all interested communities in Lawrence County.

BE IT FURTHER RESOLVED, The historic properties, with emphasis on those properties appropriate for use in the observance of the bicentennial;

- (a) Restoration of historic properties, with emphasis on those properties appropriate for use in the observance of the bicentennial;
- (b) Local historic preservation programs and activities;
- (c) Local archaeological programs and activities;
- (d) Educational Programs;
- (e) Bibliographical and documentary projects;
- (f) Conferences, lectures, seminars, and other programs;
- (g) Museum, library, cultural center, and park improvements, services, and exhibits, including but not limited to a bicentennial commemorative painting and mobile exhibits;
- (h) Tourism attractions; and
- (i) Ceremonies, celebrations, and observances.

BE IT FURTHER RESOLVED, Subject to existing statutes, rules, and policies, the committee may procure office space and supplies necessary to enable it to effectively carry out planned celebrations. The committee may enter into such contractual and promotional agreements necessary to effectively stimulate a county-wide program of celebrations.

BE IT FURTHER RESOLVED, If legislative authority permits,



the 1996 Tennessee Bicentennial Committee of Lawrence County is authorized to create a non-profit corporation with the approval of the County Executive. Upon its incorporation, this entity shall be responsible for implementing such programs as the committee plans. The non-profit corporation may hire such support staff and name such advisory groups or steering committees as necessary to assist in the promotion, coordination, and implementation of and fundraising for the comprehensive program for the bicentennial developed by the committee; provided, however, that costs to underwrite such activities shall be borne from revenues of the non-profit corporation and no county or municipal employee shall benefit from such proceeds.


BE IT FURTHER RESOLVED, Subject to existing state or local law, the committee may disburse legislatively appropriated funds for planning and for commemorative programs and activities.

BE IT FURTHER RESOLVED, The 1996 Tennessee Bicentennial Committee of Lawrence County may take such other action as is necessary and appropriate to promote, effectuate and further the principles and aims of this resolution.

BE IT FURTHER RESOLVED, The 1996 Tennessee Bicentennial Committee of Lawrence County as established by this resolution shall cease to exist on April 15, 1997.

WHEREAS, Tennessee Code annotated, Section 67-5-102

(a) (1) authorizes counties to levy an ad valorem tax upon all property subject to such tax, and

WHEREAS, Tennessee Code Annotated, Section 67-5-102 (a) (2) directs that the amount of such tax shall be fixed by the county legislative body of each county, and

WHEREAS, the rounding of ad valorem property tax amounts to the nearest dollar would simplify and expedite the payment and collection of property taxes in the county,

NOW, THEREFORE, BE IT RESOLVED by the Lawrence County Board of Commissioners meeting in regular session this 25th day of July, 1994, directs that individual ad valorem property tax amounts be rounded to the nearest dollar. Such rounding shall be applied uniformly to all property tax bills in the county for real and personal property, and shall be accomplished by rounding amounts ending in \$0.01 to \$0.49 down to nearest dollar and amounts ending in \$0.50 to \$0.99 up to nearest dollar. Such rounding shall apply only to the amount, and not to any interest or penalty added to delinquent taxes.

THIS RESOLUTION SHALL be effective for the 1994 tax year, the public welfare requiring it.

WHEREAS, the office of the Clerk and Master is desirous of being removed from being paid on a fee basis; and

WHEREAS, pursuant to I.C.A. §8-24-104, the legislative body in any county may make the necessary appropriation and pay to a Clerk and Master the maximum salary fixed by I.C.A. §8-24-102, and the authorized expenses fixed by law for the operation of the office, including the salary of all deputies, which will be the sole manner of compensation for those deputies, as authorized by law, such payment to be direct from the County Trustee in 12 equal monthly installments, irrespective of the fees earned by such officers.

NOW, THEREFORE, be it resolved by the Lawrence County legislative body meeting in regular session this 19th day of July, 1993, that the office of the Clerk and Master of Lawrence County, Tennessee, will be compensated the maximum salary as fixed by law and the authorized expenses fixed by law for the operation of her office, including the salaries of all deputies, which shall be the sole manner of compensation for those deputies, pursuant to Chapter 20 of Title 8 of Tennessee Code Annotated, which payment will be direct from the County Trustee in 12 equal monthly installments irrespective of the fees earned by such officers. That furthermore, all fees allowed, collected or in any manner received by such officers will be paid, assigned, transferred and set over to the County monthly, and when such fees are received by the Clerk and Master, such fees shall be transmitted monthly to the County Trustee.
