



RESOLUTION FOR THE CLEANUP OF OVERGROWN VEGETATION  
AND VACANT DILAPIDATED BUILDINGS OR STRUCTURES

WHEREAS, T.C.A. Sec. 5-1-115 authorizes counties to impose regulations upon property owners to prevent and eliminate overgrown vegetation, and vacant dilapidated buildings and structures, and

WHEREAS, the citizens of Lawrence County are desirous of improving the environment and reducing the risks to health posed by overgrown vegetation and/or vacant dilapidated buildings and structures, on private property within Lawrence County;

NOW, THEREFORE, BE IT RESOLVED by the county legislative body of Lawrence County that the following regulations are adopted:

REGULATION 1. DEFINITIONS: As used in this

Resolution, the following words have the following meanings:

- (a) Overgrown vegetation means the growth of trees, vines, grass, underbrush above or in combination with the accumulation of debris, trash, litter or garbage.
- (b) Vacant dilapidated building means a structure which is not an over-occupied residence and which cannot feasibly be repaired to be a substantial and durable building, or a structure which is not an owner-occupied building which in its state of non-repair encourages the infestation of rats and other harmful animals, or poses a danger to the health, safety or welfare of the citizens of Lawrence County.

REGULATION 2. The county executive shall designate an existing county officer or employee or shall employ a person to enforce the provisions of these Regulations. The person

designated or employed by the county executive to enforce these Regulations shall be compensated for these duties in an amount to be determined by the county executive within the amount of funds appropriated for such purpose from the county general funds.

REGULATION 3. No owner, occupant or resident of any real property shall permit or allow overgrown vegetation and/or vacant dilapidated buildings or structures to exist upon such real property to the extent that it endangers the health, safety, or welfare of the citizens of Lawrence County.

REGULATION 4. The owner, occupant or resident of real property where such overgrown vegetation and/or vacant dilapidated buildings or structures exist shall take appropriate measures to clean up such overgrown vegetation and removal of such vacant dilapidated buildings or structures.

REGULATION 5. The clean-up and removal of such overgrown vegetation and vacant dilapidated buildings or structures shall be accomplished in a manner and at a time so that it does not further endanger the citizens of the county.

REGULATION 6. The clean-up and removal of such overgrown vegetation and vacant dilapidated buildings or structures shall include the transfer to an appropriate and lawful dump site, whether public or private, or to an appropriate place for lawful disposal, in a manner and at a time that does not further endanger the inhabitants of the county.

REGULATION 7. If the person designated or employed by the county executive to enforce these Regulations determines that a violation of these Regulations exists, the person shall provide notice to the owner of record of the property upon which the condition creating the violation is located to remedy the condition immediately. The notice shall be by personal service on the owner or by mailing by United States mail (certified, return receipt requested) to the owner of record at

the last known address. The notice shall be in writing and in plain language and shall also include but not be limited to the following items:

- a. a brief statement identifying these Regulations and the consequences for failing to remedy the noted condition.
- b. the person, office, address, and telephone number of the department or person giving notice.
- c. a cost estimate for remedying the noted condition which shall be in conformity with the standards of cost in the community.
- d. a brief statement informing the recipient of the notice that the property owner may request a hearing within ten (10) days of the date of the receipt of the notice.

3. the place where the recipient of the notice can return a copy of the notice indicating a request for a hearing.

REGULATION 8. If a violation of these Regulations is not remedied within twenty (20) days following personal service of the notice or following the mailing of the notice, as the case may be, or if a hearing is held as provided in these Regulations, within twenty (20) days following the hearing if the violation persists, the county executive or his designee or employee shall remedy the condition causing violation by one of the following methods:

- a. by contracting with a private party for the job in accordance with any purchasing laws in effect, or
- b. by reaching agreement with the chief administrative officer of the county highway department for that department to remedy the condition. If this option is used, the highway fund shall be reimbursed for the cost of the job from the general fund.

REGULATION 9. The cost of all remedies effected by the county executive or his designee or employee shall be defrayed from general fund appropriations for this purpose, but the general fund shall be reimbursed by the property owner in

accordance with these regulations. If the county remedies a condition causing a violation, the county executive's designee or employee shall send a statement by certified mail (return receipt requested), to the property owner itemizing the cost of remedying the condition causing the violation. If such owner fails to reimburse the county general fund for the cost of the remedy within sixty (60) days of receiving the statement of cost, such statement shall constitute a lien upon the land in favor of the county. Such statements shall constitute a lien upon such real property as of the date notice is filed in accordance with Tennessee Code Annotated, Section 39-14-504.

The lien provided herein shall be entered in the records of the register of deeds of this county. Such lien shall be satisfied to the extent of the value of the consideration received at the time of transfer of ownership, and if the lien is not fully satisfied at the time of transfer, it shall remain a lien on the property until it is fully satisfied.

REGULATION 10. If a request for a hearing is made by the property owner within twenty (20) days of the receipt of the notice issued pursuant to Regulation 7 as provided in these Regulations, the person designated by the county executive to enforce these Regulations shall act as hearing officer and shall within a reasonable time following the request hold a hearing on the issue of the requirements imposed on the landowner and the issue of cost of removal of such vegetation or building. Failure to make the demand for a hearing within the time limit allowed by these Regulations shall constitute a waiver of the right to a hearing. Immediately following the hearing, the hearing officer may modify or dismiss the notice or may confirm the notice.

REGULATION 11. Any person aggrieved by an order or act of the board, agency or commission under the provisions of this resolution may seek judicial review of the order or may appeal to the Chancery Court of Lawrence County within ten (10)

days of the order or act of said board. The time period established in Regulation 8 shall be stayed during the pendency of a hearing.

REGULATION 12. Any proceedings other than those listed herein also shall conform to the provisions of Tennessee Code Annotated, Section 39-14-504.

BE IT FURTHER RESOLVED that, after passage, the county clerk shall cause this resolution to be published in a newspaper of general circulation in this county, and that this resolution shall become effective seven (7) days after such publication, but no sooner than July 1, 1995, the public welfare requiring it.

TO ESTABLISH WRITTEN PROCEDURES GOVERNING  
PURCHASES AT PUBLICLY ADVERTISED AUCTIONS

**WHEREAS**, Chapter 795 of the Public Acts of 1994 authorizes counties to purchase new or secondhand articles or equipment or other materials, supplies, commodities and equipment at any publicly advertised auction without the necessity of using the public advertisement and competitive bidding process; and

**WHEREAS**, Chapter 795 of the Public Acts of 1994 requires the county legislative body to establish written procedures to govern purchases at public auctions;

**NOW, THEREFORE, BE IT RESOLVED** by the county legislative body of Lawrence County, meeting in regular session at Lawrenceburg, Tennessee, on the 27 day of March, 1994, that the following procedures are established to govern purchases at publicly advertised auctions:

1. All purchases at public auction must be initiated by the county official having responsibility for the department for which the purchase is to be made. The county official must complete a "Request for Purchase at Public Auction", the form of which is attached to this resolution as Attachment A and made a part of this resolution. The completed form must be approved by the purchasing agent (if different from the county official) for the department for which the purchase is to be made.
2. The county official (and the purchasing agent, if different from the county official) must certify that the proposed purchase is within the appropriate budget, and that sufficient cash is and will be on hand to make the proposed purchase on the date of purchase.
3. No tax shall be paid on any item purchased at public auction, except to the extent that no exemption is available to the county under applicable law.
4. Purchases shall be made only by county warrant or county check.
5. The public auction must be conducted by an auctioneer who is licensed to conduct auctions in the State of Tennessee. Any item purchased at public auction shall be accompanied by the vendor's certification that the item is free from any liens or encumbrances.
6. The purchasing agent, or another person designated by the purchasing agent, shall act as bidder for the county at the auction. The bidding shall be in accordance with the Request for Purchase at Public Auction and the bid shall not exceed the maximum authorized price. If the county is the successful bidder, the bidder must complete and sign a "Certification of Purchase at Public Auction", the form of which is attached to this resolution as Attachment B and is made a part of this resolution.

7. The Request for Purchase at Public Auction and the Certification of Purchase at Public Auction, properly completed and signed, shall be filed with the purchasing agent within twenty-four (24) hours after the auction. The purchasing agent shall mail or deliver copies to the chairman of the county legislative body within five (5) days after the auction.

BE IT FURTHER RESOLVED, that a copy of this resolution be distributed by the County Clerk to each county official and department head in Lawrence County.

This resolution shall take effect upon adoption, the public welfare requiring it.
