**RESOLUTION FOR LEVYING AN ADDITIONAL SALES AND
USE TAX IN LAWRENCE COUNTY**

BE IT RESOLVED by the county legislative body of Lawrence County,
Tennessee:

SECTION 1. The resolution of the county legislative body of Lawrence County, Tennessee, imposing a local sales and use tax as authorized under the provisions of 67-6-701 through 67-6-712, *Tennessee Code Annotated*, adopted by the county legislative body at a regular meeting of record in Minute Book 13, Page 110, is amended to levy a local sales and use tax at a rate of two and three quarters percent (2.75%), not to exceed the maximum percentage as stated in the **RETAILERS TAX ACT**, Tennessee Code Annotated 67-6-702, as amended, except as limited of modified by statute.

SECTION 2. If a majority of those voting in the election required by *Tennessee Code Annotated* 67-6-706 vote for the increase in the tax imposed by this resolution, collection of the increased tax levied by this resolution shall begin on the first day of the month occurring thirty (30) or more days after the county election commission makes its official canvass of the election returns.

SECTION 3. The Department of Revenue of the State of Tennessee shall collect the additional tax imposed by this Resolution concurrent with the collection of the state tax and the local tax now being collected for Lawrence County, in accordance with rules and regulations promulgated by the Department.

SECTION 4. The County Executive is hereby authorized to contract with the Department of Revenue for the collection of the additional tax imposed by this Resolution, and to provide in the contract that the Department may deduct from the tax collected a reasonable amount or percentage to cover the expense of the administration and collection of the tax.

SECTION 5. In the event the tax is collected by the Department of Revenue, suits for the recovery of any tax illegally assessed or collected shall be brought against the State Commissioner of Revenue and the County Executive.

SECTION 6. A certified copy of this Resolution shall be transmitted to the department of revenue by the County Clerk forthwith and shall be published one time in a newspaper of general circulation in Lawrence County prior to the election called for in Section 2 hereof.

**A RESOLUTION TO REMOVE THE EXISTING SINGLE
ITEM LOCAL SALES TAX LIMIT AND TO APPLY THE
EXISTING SALES TAX RATE**

WHEREAS, the General Assembly of the State of Tennessee has authorized in *Tennessee Code Annotated* section 67-6-702 for counties to specify applicable limits in the local option sales tax collectible on the sale or use of any single article of personal property up to the first one thousand six hundred dollars (\$1,600.00) on the sale or use of any single article of personal property.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Lawrence County, Tennessee, meeting in special session on the 23rd day of October, 1995, and in special session on the 30th day of October, 1995, that:

SECTION 1. The maximum local option sales tax collectible on the sale or use of a single item of personal property as authorized in the resolution of the county legislative body which levied the local option sales tax for Lawrence County, of record in Minute Book 13 at page 111, is hereby removed.

SECTION 2. Beginning on the first day of the month occurring thirty (30) or more days after a certified copy of this resolution is received by the Department of Revenue, the local sales tax at the present rate effective in Lawrence County shall apply to the first one thousand six hundred dollars (\$1,600.00) on the sale or use of any single article of personal property, as provided in Tennessee Code Annotated sec 67-6-702.

SECTION 3. Nothing herein contained shall be construed to increase the local option sales tax rate heretofore in effect in Lawrence County.

SECTION 4. Notice of the meetings for the consideration of this Resolution and that this matter is on the agenda of the meetings has been published at least once in a newspaper of general circulation in Lawrence County as required by Tennessee Code Annotated sec 67-6-702(a)(2).

SECTION 5. A certified copy of this Resolution shall be transmitted to the Department of Revenue of the State of Tennessee by the County Clerk and shall be spread upon the record of the Board of County Commissioners.

SECTION 6. The maximum tax on the sale or use of any single item authorized by this Resolution and by Tennessee Code Annotated section 67-6-702 shall be collected by the State Department of Revenue concurrently with the collection of the state tax and the Lawrence County sales tax and in the same manner as these taxes are collected in accordance with the rules and regulations promulgated by said Department.

SECTION 7. For purposes of collection, this Resolution shall take effect on the first day of the month occurring thirty (30) or more days after a certified copy is received by the Department of Revenue; for all other purposes it shall be effective upon passage by a majority vote of the Board of County Commissioners of Lawrence County at two consecutive public meetings as required by Tennessee Code Annotated section 67-6-702.
