WHEREAS, the county legislative body of Lawrence County desires that the speed limit on BREWER ROAD shall be reduced to 35 m.p.h to protect the safety of the public.

SECTION 1: The speed limit on BREWER ROAD shall be reduced to 35 m.p.h.

SECTION 2: That appropriate road signs be posted to give notice of such reduced speed limit.
