

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF TENNESSEE:

SECTION 1. The Motor Vehicle Tax for Lawrence County, Tennessee, Private Acts of 1984, Chapter 178 and Amendments thereto is hereby repealed:

SECTION 2. This Act shall have no effect unless it is approved by a two-thirds (2/3) vote of the county legislative body of Lawrence County.
