RESOLUTION # 01091697

RESOLUTION TO DISSOLVE THE LAWRENCE COUNTY SOLID WASTE AUTHORITY

WHEREAS, the legislative body of Lawrence County has authority pursuant to Tennessee Code Annotated §68-211-924 to dissolve the Lawrence County Solid Waste Authority; and

WHEREAS, the legislative body of Lawrence County desires to be responsive to the citizens of Lawrence County whom the legislative body represents and who have expressed dissatisfaction with the creation and operation of the Lawrence County Solid Waste Authority; and

WHEREAS, all functions and services performed by the Lawrence County Solid Waste Authority can be performed by Lawrence County government.

NOW, THEREFORE, BE IT RESOLVED by the legislative body of Lawrence County meeting in special session this 16th day of September, 1997 that Resolution # 01043096 is hereby repealed and the Lawrence County Solid Waste Authority is abolished. All assets and liabilities of the Lawrence County Solid Waste Management Authority, with the exception of closure and post-closure costs which have accrued prior to July 1, 1997, shall be transferred to and assumed by Lawrence County and all disposal fees received thus far from Lawrence County citizens shall be returned to the citizens who remitted the fees.

The County Clerk shall certify copies of this resolution and shall send copies of same to the Secretary of the State of Tennessee and to the Commissioner of Environment and Conservation.

The Chairman, Vice Chairman and Secretary of the Lawrence County Solid Waste Authority are hereby authorized to transfer all funds of the Lawrence County Solid Waste Authority to account # 209 for Lawrence County Solid Waste Services.

This resolution shall take effect upon its adoption and approval, the public welfare requiring it.

RESOLUTION # 02091697

RESOLUTION ESTABLISHING LAWRENCE COUNTY SOLID WASTE SERVICES

WHEREFORE, there has been widespread dissatisfaction with the creation and operation of the Lawrence County Solid Waste Authority among Lawrence County citizens; and

WHEREAS, the legislative body desires that solid waste be disposed in an efficient and effective manner in Lawrence County.

NOW THEREFORE BE IT RESOLVED by the legislative body of Lawrence County meeting this 16th day of September, 1997, that:


1. Lawrence County Solid Waste Services be established pursuant to Tennessee Code Annotated §5-19-103(1).
2. Lawrence County Solid Waste Services shall be under the direct supervision of the County Executive's office for the remainder of fiscal year 1997-98.
3. The Lawrence County Landfill continue to operate with such services to be for the convenience of all Lawrence County citizens.
4. Lawrence County Solid Waste Services shall be funded by the General County Fund balance and by surcharge tipping fees for industrial users in the amount of \$22.00 per ton.
5. Collection of Solid Waste shall be continued under the present system of collection, whether by municipal collection or by private hauler collection.
6. Lawrence County Solid Waste Services shall be operational immediately upon the approval of the Lawrence County Commission.
7. The Lawrence County Office of Accounts and Budgets shall be responsible for payroll and other accounting of the Lawrence County Solid Waste Service, with all records to be subject to an annual state audit.
8. A study shall be done to evaluate the feasibility of continued solid waste disposal under the Lawrence County Solid Waste Services and to make recommendations for its continuation or alternative systems after July 1, 1998.

This resolution shall become effective upon its adoption and approval, the public welfare requiring it.
