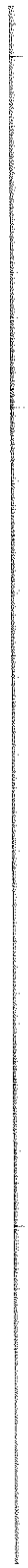



**WHEREAS**, the legislative body of Lawrence County desires that the Lawrence County Solid Waste Services continue to provide services to Lawrence County citizens, to be supervised by the legislative body of Lawrence County for the remainder of fiscal year 1998-1999.

**RESOLUTION TO REACTIVATE THE LAWRENCE COUNTY  
PLANNING COMMITTEE**

**WHEREAS**, the Tennessee Code Annotated §13-3-101 authorizes counties to establish a planning commission for the purpose of examining land use within unincorporated areas of Lawrence County; and

**WHEREAS**, such planning commission was originally established by the legislative body of Lawrence County May 16, 1966; and

**WHEREAS**, such previous commission has since become inactive; and

**WHEREAS**, a planning commission is required to be in place to make recommendations as to whether flood plain regulations should be implored in Lawrence County which may allow its citizens to participate in the national flood insurance program.


**NOW, THEREFORE, BE IT RESOLVED** by the legislative body of Lawrence County meeting in special session this 21st day of September, 1998 that the Lawrence County regional planning commission be reactivated for the purpose of examining land use within the unincorporated areas of Lawrence County and that seven members be appointed by the County Executive, subject to confirmation by the county legislative body. Such membership may include members of the legislative body, with the provision that any such members from the legislative body or other county officials shall comprise a minority of such commission and that the term of the appointed membership be four years, except that the terms of three of the members first appointed shall be one, two and three years respectively. Any commissioner or other elected official serving on the Lawrence County Regional Planning Commission shall have a term coterminous with his or her elected term.


