**WHEREAS**, Lawrence County has adopted a personnel policy manual to provide guidelines for all county employees as well as supervisors; and

**WHEREAS**, certain updates and changes need to be made.

**NOW, THEREFORE, BE IT RESOLVED**, by the legislative body meeting in regular session this 27th day of April, 1999 that the following changes be made to the Lawrence County


Personnel Policy Manual:

1. Omit the second sentence of paragraph (2) under "F. Vacation" (page 6 of manual) and insert "Any vacation time exceeding fifty (50%) percent of the time accumulated in any work year will be converted to sick days."
2. Delete paragraph 2 of "E. Reimbursement for Meals" (page 26 of manual) and insert "Breakfast may be claimed for reimbursement if the travel departure time is before 7:00 a.m. or if the return time is after 8:00 a.m.. Breakfast reimbursement will be no more than twenty-five (25%) percent of the per diem rate allowed by the IRS. Likewise, lunch may be claimed for reimbursement if the departure time is before 11:00 a.m. or if the return time is after 1:30 p.m.. Lunch reimbursement will be no more than thirty-one (31%) percent of the per diem rate. Dinner meal will be reimbursed if the travel originates before 5:00 p.m. or is completed after 6:30 p.m. or if overnight travel is involved. Dinner reimbursement will be no more than forty-four (44%) percent of the per diem rate. Some travel reimbursement is taxable income to the employee."

These changes shall take effect May 1, 1999.
