AMENDED RESOLUTION NO. #02122701

AMENDED RESOLUTION TO RELOCATE THE OFFICE OF THE LAWRENCE COUNTY ELECTION COMMISSION TO THE LAWRENCE COUNTY COURTHOUSE ANNEX

WHEREAS, the Lawrence County Election Commission is presently located on the second floor of the Lawrence County Courthouse with limited office space of approximately 330 square feet; and

WHEREAS, there is approximately 500 square feet of office space available in the Lawrence County Courthouse Annex (known as Lawrence County Senior Citizens Building), said office space being located on the ground floor of the Annex and said space will provide additional space to the Lawrence County Election Commission and will provide the Lawrence County Election Commission with a private entrance and the ability to share storage space with the Lawrence County Housekeeping Department; and

WHEREAS, the Facilities Committee of the Lawrence County Commission deems that it is in the best interest of the citizens of Lawrence County to locate the office of the Lawrence County Election Commission in the Lawrence County Courthouse Annex in order to provide better accessibility to said office with a ground floor entrance and in order to provide increased security and privacy for those who choose to take advantage of early voting or have other business to conduct at the offices of the Lawrence County Election Commission.

NOW, THEREFORE, be it resolved by the Lawrence County legislative body meeting in special session this 27th day of December, 2001, that the office of the Lawrence County Election Commission shall be relocated to the Lawrence County Courthouse Annex, that any cost of said relocation shall be paid out of the County General fund and that said move shall commence after the May, 2002 primary election.

This resolution will take effect upon its passage, the public welfare requiring it.
