

FOR THE FISCAL YEAR BEGINNING JULY 1, 2003, AND TO AUTHORIZE  
THE EXPENDITURE OF FUNDS BY THE VARIOUS COUNTY OFFICES  
AND DEPARTMENTS

WHEREAS, it now appears that the fiscal year 2003- 2004 budget of Lawrence County, Tennessee, will not be approved by July 1, 2003;

NOW, THEREFORE, BE IT RESOLVED, by the county legislative body of Lawrence County, Tennessee, meeting in special session on this 23rd day of June, 2003, that:

SECTION 1. The amount set out in the fiscal 2002 - 2003 Appropriations Resolution are continued and the various departments, offices and agencies are authorized to expend funds at the same level as the previous fiscal year.

SECTION 2. The property tax rate of \$2.625 per each \$100 of taxable property for the fiscal year beginning July 1, 2003, will remain in effect until a new property tax rate is adopted.

SECTION 3. No local funds can be expended or obligated that exceed the previous year's budget appropriation until a new budget is adopted. Expenditures mandated by the State or rules and regulations adopted by the State are incorporated into this continuing budget.

SECTION 4. The County Executive and County Clerk are hereby authorized to borrow money on tax anticipation notes, not exceeding 60% of the appropriations of each individual fund of the continuing budget, to pay for the expenses herein authorized until the taxes and other revenues for the fiscal year 2003 - 2004 have been collected. Such notes shall first be approved by the State Director of Local Finance. The notes evidencing the loans authorized under this section shall be issued under the authority of Title 9, Chapter 21, *Tennessee Code Annotated*. All of said notes shall mature and be paid in full without renewal not later than June 30, 2004.

SECTION 5. This resolution will take effect from and after its passage and its provisions will be in force from July 1, 2003, until the budget and tax rate for fiscal year 2003 - 2004 is finally adopted and approved. The County Clerk shall include this Resolution in the minutes of the Lawrence County legislative body and send a copy to each department head.



NOW, THEREFORE, BE IT RESOLVED that the Lawrence County Sheriff's Department is hereby authorized to collect the following fees:

- All proceeds from the inmate phone system not otherwise obligated;
- All incentive pay received from the State of Tennessee for returning invalid drivers' licenses;
- A \$5.00 fee for recent law enforcement reports (less than two years old from date of request);
- A \$20.00 fee for law enforcement reports already archived (more than two years old from date of request);
- A \$45.00 fee for fingerprinting non-law enforcement related applicants; and
- A \$5.00 per day fee for storing vehicles seized during law enforcement operations.

It is further RESOLVED that all revenue gained from these specific sources shall be placed into the special fund, commonly called the Sheriff's Technology Improvement Fund, for the express purpose of upgrading or improving computer technology of the Lawrence County Sheriff's Department.


