RESOLUTION TO PROVIDE FOR THE DESIGN AND RENOVATION OF A PORTION OF THE SOLID WASTE TRANSFER STATION TO BE USED AS A TEMPORARY JAIL FACILITY FOR LAWRENCE COUNTY

Jail was closed on May 3, 2006; and WHEREAS, by order of the Tennessee State Fire Marshall, the Lawrence County

County Jail, however, only 34 immates can be housed in the jail facility; and WHEREAS, Lawrence County government has renovated the existing Lawrence

incarceration being approximately \$45.00 per day per inmate not including transportation approximately 100 inmates thus requiring Lawrence County government to incarcerate inmates in other county jail facilities throughout the state with the present cost of such WHEREAS, the average inmate population of the Lawrence County Jail is

possibly much longer; and WHEREAS, Lawrence County is in the process of constructing a new jail facility, however, according to the architectural firm designing the jail, the estimated date for completion and occupancy of the new jail will be at least two years from the present and

inmates for the next 24 or more months, will greatly deplete the General Fund of the Lawrence County budget; and WHEREAS, to continue to pay other counties to house Lawrence County Jail
