RESOLUTION NO. 2008090201

RESOLUTION TO DIRECT THE LAWRENCE COUNTY ELECTION COMMISSION TO
CALL AN ELECTION ON THE QUESTION OF WHETHER OR NOT LAWRENCE COUNTY
SHOULD LEVY AN ADDITIONAL COUNTY-WIDE MOTOR VEHICLE TAX

WHEREAS, on May 27, 2008, at its regularly scheduled meeting, the Lawrence County Legislative Body enacted Resolution No. 2008052713 which resolution levied an additional motor vehicle privilege tax in the amount of \$25.00 for every motor driven vehicle and \$15.00 for every motorcycle or motor driven bicycle and scooter, the owner of which resides within Lawrence County; and

WHEREAS, on July 22, 2008, at its next regularly scheduled meeting, the Lawrence County Legislative Body enacted Resolution No. 2008072203, identical to Resolution No. 2008052713 which likewise levied an additional motor vehicle privilege tax in the amount of \$25.00 for every motor driven vehicle and \$15.00 for every motorcycle or motor driven bicycle and scooter, the owner of which resides within Lawrence County; and

WHEREAS, pursuant to T.C.A. § 5-8-102, if there is a petition of registered voters amounting to ten percent (10%) of the votes cast in Lawrence County in the last gubernatorial election that is filed with the County Election Commission within thirty days of final approval of such resolution by the County Legislative Body, then the County Election Commission shall call an election on the question of whether or not the tax should be levied in accordance with the provisions of T.C.A. § 5-8-102; and

WHEREAS, the Lawrence County Election Commission has advised the Lawrence County Legislative Body that a qualified petition has been filed with the Lawrence County Election Commission calling for such election; and

WHEREAS, pursuant to T.C.A. § 5-8-102(c)(3), it is the responsibility of the Lawrence County Legislative Body to direct the Lawrence County Election Commission to cause such election to be held at the next regular election for the purpose of approving or rejecting such tax levy; and

WHEREAS, there is an upcoming regular election on November 4, 2008, which would be the appropriate time to have an election approving or rejecting the aforesaid tax levy.

NOW, THEREFORE, BE IT RESOLVED by the Lawrence County Legislative Body meeting in special session this 2nd day of September, 2008, the following:

1. The Lawrence County Election Commission is directed to call an election for November 4, 2008, for the purpose of approving or rejecting the additional motor vehicle tax levy;
2. The ballots shall have printed on them the substance of this resolution;
3. The proposition which shall appear on the ballot shall be substantially as follows:

Shall the resolution passed pursuant to T.C.A. § 5-8-102, by the Lawrence County Commission, which levies an additional motor vehicle privilege tax in the amount of Twenty-Five Dollars (\$25.00) for every motor driven vehicle and Fifteen Dollars (\$15.00) for every motorcycle or motor driven bicycle and scooter, the owner of which resides in Lawrence County, be approved?

4. Pursuant to Section 9 of the enabling resolutions, the collection of the tax therein levied shall begin on the first day of the month following the month that this resolution is approved at a referendum.

This Resolution shall take effect upon its passage, the public welfare requiring it.
